II. <u>PUBLIC HEARINGS:</u>

A. PUBLIC HEARING FOR A SPECIAL LAND USE PERMIT FOR AN OUTSIDE MUSIC VENUE – 129 EAST ALLEGAN STREET, MAUDE'S LLC
